- 4. Maastricht Congress 2018

- 6. Mail
 - 18th April 2016: mail from Dr. D. Kakarigi offering to host the Council meeting in fall 2017.
 - 25th May 2016: mail from Dr. J. Margalho Carrilho: unfortunately he could not attend the Ljubljana Congress, but he plans to attend the fall Council meeting in 2016 and bring his deputy Dr. Anabela Alves. In Fall 2016 the 1st post-graduation course in Social Security Medicine will start (based on the Belgian curricula) at the Portuguese Catholic University.
- 7. Any other business
 - Call for abstracts for the annual Dutch International Congress on Insurance Medicine (deadline 1st July 2016)
 - Dr. W. de Boer is leaving the Council with mixed feelings, but he will stay on the Scientific Committee. He will miss several contacts, but he is happy to return to the Netherlands...and to his granddaughter. Over the past years the level of EUMASS has risen and that is satisfactory, but he is concerned about recent meetings where EUMASS acted political vs professional; was defensive and self-centred vs open. That is a worrying development.
 - Dr. G. Lindenger thanks Dr. de Boer for his great contribution to EUMASS and the French delegation thanks Dr. W. de Boer for his hard work on the Scientific Committee.
 - The French delegation thanks the Slovenian representatives for organising a great congress.
 - The secretariat will send out a reminder of the invoice to those members who have not paid yet shortly.
 - Given the long preparation time required for the organisation of a EUMASS Congress, members are asked to consider their candidature for organising the 2020 Congress.
 - The Swedes have made a scenario, which could help future Congress organisers. It is supposed to be a living tool, so the Slovenes are asked to add relevant information.
